ORGANIZATIONS RECEIVING MANAGED SERVICES HAVE THE BENEFITS OF ONGOING BACKUP, ANTIVIRUS, AND MONITORING OF THEIR NETWORKS. THESE SERVICES ALLOW NONPROFITS THAT RANGE FROM THREE TO HUNDREDS OF EMPLOYEES KEEP THEIR DATA SAFE, WORK EFFICIENTLY, COMMUNICATE EFFECTIVELY, AND TRACK RELATIONSHIPS AND RESULTS.

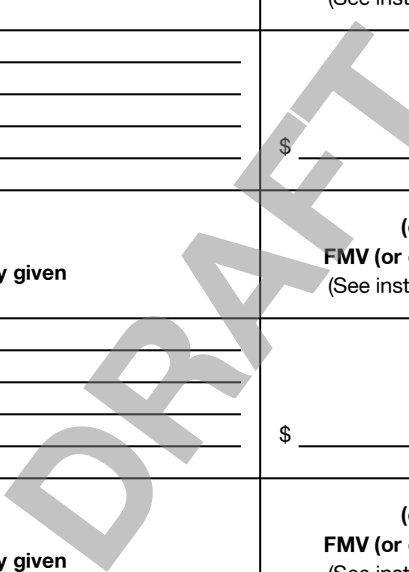

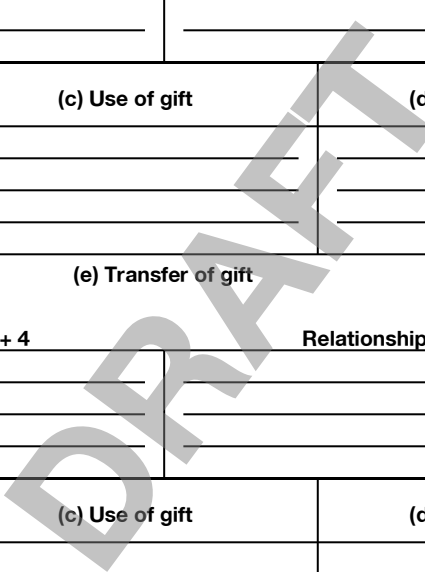
