1 Briefly describe the organization's mission: We all rise when nonprofits thrive. At 501 Commons we serve nonprofits as experts, innovators, and partners. Our passion is to amplify the strengths of nonprofits - so ALL people and communities flourish.

4a (Code: ) (Expenses \$ 1,797,626. including grants of \$ ) (Revenue \$ 1,233,054. ) Our technology consulting services include database development and maintenance, technology planning, the 501 Talks Tech training series, and IT infrastructure services. We maintain the IT infrastructure of 62 organizations, including providing rapid assistance through our Help Desk. Overall technology was involved in 229 engagements with 112 organizations.

4b (Code: ) (Expenses \$ 812,311. including grants of \$ ) (Revenue \$ 451,378. ) Management Services includes human resources, leadership coaching, executive advising, management consulting, organizational assessments, volunteer management consulting and emergency planning. In 2020, we completed 317 projects with 231 organizations. In areas other than human resources, most of the services are provided by skilled volunteers who are members of our Executive Service Corps. Overall, service corps members contributed time valued at \$1.6 million in 2020.

Our Human Resources practice worked on 215 projects with 140 organizations, primarily in Washington and Oregon. Thirty-six organizations were engaged in HR Partnerships. Over 900 people participating in training and peer learning sessions.

4c (Code: ) (Expenses \$ 722,651. including grants of \$ ) (Revenue \$ 745,384. ) In 2020, we served over 205 organizations of various sizes with financial services and consulting. There were 356 services provided including accounting and bookkeeping, best practices consultations, tax filings, free assistance with the Paycheck Protection Program. The growth in this area is due to the free PPP loan and loan forgiveness applications we did, resulting in \$2.7 million in loans. Many of these organizations also received second forgivable loans. By providing services at affordable rates, our clients are able to focus on their mission and have the financial data they need to make sound management decisions.

We all rise when nonprofits thrive. At 501 Commons we serve nonprofits as experts, innovators, and partners. Our passion is to amplify the strengths of nonprofits - so ALL people and communities flourish.

**Form 990, Part III, Line 4d, Other Program Services:**

GiveBIG raised \$19.2 million in on-line donations, matching funds and gifts, DAF and IRA donations, and in-kind contributions. This was a 53% increase. Donors nearly doubled. The number of participating organizations grew to 1,682, a 9% increase. We made the fundraising platform used for GiveBIG, which is provided through our partnership with Neon One, available on a year-round basis and raised an additional \$400,000 through Giving Tuesday and year-end giving. Nine organizations serving immigrants participated in the GiveBig Campaign Assistance Program and increased their donations overall by 212% for a total of \$134,000.
